INFORMATION ON SWIMMING POOLS

1. Above ground pools - Ladder must be able to swing up when pool not in use.
45" clearance from ground level to top.
4' sides for pool.
2. In ground pools - Must be enclosed with fence. Self-closing & self-locking mechanisms are needed at all entrances to the pool. (At doors from house an alarm is required). The fence must be 4' in height.
3. Pools with decks - Alarm at doors of house leading to the pool, and self-closing & self-locking mechanisms at all gates. Rails around decks must be 36 inches high.
4. Must maintain a 10' clearance from property lines.
